Review all clubs and ensure that they are inclusive. <i>Monitor the participation of all disabled pupils at extra curricula clubs.</i> Review additional arrangements in place for disabled access to class assemblies, sports day, etc (linked to physical access action plan)	SENDCO in liaison with club leaders.
